- c. Complete Application Form along with all necessary Documents duly signed by existing Corporate Member (FIE/MIE/AMIE) must be sent by the Applicant directly to the Headquarters of the Institution at 8 Gokhale Road, Kolkata 700 020 and NOT through any Agency.
- d. Applicants are advised to keep the photocopies of the filled in Application Form along with the demand draft and all documents attached therewith for information and future reference.
- e. Any deficiency/discrepancy in the Application Form is intimated by sending a Letter to the Applicant.
